The Blackstone Legal Fellowship prepares Christian law students for careers marked by integrity, excellence, and leadership.


The Fellowship begins with a nine-week summer leadership training program. Interns participate in three weeks of seminars and interactive discussion on topics including legal philosophy, constitutional law, history, and emerging cultural issues, and also perform a six-week legal internship.

Interns emerge with a professional network, enduring friendships, and a foundation of knowledge that will serve them throughout their careers. Those selected to become “Fellows” also receive ongoing training, resources, and support through an international community.

PHASE I


Interns engage with leading minds in the areas of philosophy, jurisprudence, political science, and social science. Together, they explore pressing cultural issues and challenge prevalent relativistic and positivist legal thinking. The curriculum also incorporates daily worship and a devotional series.

PHASE II

Interns complete a six-week legal internship that not only develops their legal skills, but also introduces them to a network of seasoned professionals in their areas of interest. In past years, Interns have obtained internships at a wide variety of organizations, including governmental entities, boutique law firms, and nonprofits among others.

PHASE III

Interns participate in a final week of seminars and training focused on career development and cultural engagement. Interns return to law school equipped with deeper knowledge, stronger convictions, and access to a vast professional network that will continue to grow throughout their careers.
